Each certification program will consist of two full days beginning at 8:00 AM and continuing until 5:00 PM. The first day is a review of basic concrete technology and a review of the 7 ASTM test procedures covered in the examination. **This is only a review course and is designed for experienced technicians. There will be no instruction concerning the use of the test equipment for inexperienced technicians.** Day 2 will be taking the written and performance exams. Re-testing is available only to those who have failed a test and have to retake the written or performance exam within a year of first taking the exam.

**Late registration is 10 business days prior to the scheduled programs. REFUND POLICY:** A refund of \$125 will be given for the 2-day session, a refund of \$75 for written or performance retesting, if a cancellation is made 10 to 6 business days before the first day of the session. **NO REFUND** if cancellation is made **5 or less business days before the first day of the session.** Location sites, class schedules and certification workbooks will be sent to each paid registrant in the 2 day class at the address provided on the registration form. **Re-certification** payment is the same as the member or non-member fees for the full class.

Applicants will be registered on a **first-come, first-serve basis**. Fees must be received **IN ADVANCE** in order to be considered registered. Places are **NOT "reserved."** The enrollment fee for the 2 day session includes a workbook, performance and written exam, and fees for instructors, sites and certificates. **Workbooks will be sent 3 to 4 weeks before the class, provided payment has been received with the registration form.** Payment is by check made out to "ACI Carolinas Chapter" or online at the website – [www.aci-carolinas.org](http://www.aci-carolinas.org).
